NHS Somerset commissions one specialist service through Somerset Partnership NHS Foundation Trust which comprises of the Aspergers Team who provide diagnosis and health/social care for adults with autism. As such you may wish to contact <u>Somerset</u> Partnership NHS Foundation Trust to request this information.

The acute trusts for which NHS Somerset is the lead commissioner, through paediatric care, would provide some services for children with Autism. As such, you may wish to contact <u>Taunton and Somerset NHS Foundation Trust</u> and <u>Yeovil District Hospital NHS</u> <u>Foundation Trust</u> to request this information.

In addition to the NHS Health Services listed above, Somerset County Council may hold some information around the care packages that are in place for people with autism. As such, you may wish to contact <u>Somerset County Council</u> to request this information.

# Question 6 - What the typical process should be for an adult in your area first asking their GP for an assessment for autistic spectrum disorder to receiving a diagnosis/support

Once a referral from a GP has been made, this would lead to an initial assessment through the Community Mental Health team with Somerset Partnership NHS Foundation Trust. As such, you may wish to contact <u>Somerset Partnership NHS Foundation Trust</u> to request information regarding the post-referral assessment process.
